The PCSO was present at the meeting and reported the following incidents:

- Two alarm activations at a property on 19th October, both were false alarms.
- A disagreement between a shopkeeper and customer was reported on the 22nd October.
- A suspicious person was reported in a garden at a property on Knutsford Road on 6th November.
- No incidents noted from patrols at Lindow school during peak times.

7) Matters Arising 21/099

- Update on cemetery gatehouse. Sale on open market by CEC. Noted that CE had now put the cemetery gatehouse up for auction on the open market. The auction will take place on the 15th December with a guide price of £150,000.00.
- ii. Update on a new Parish Council Website Information received from website provider.

Cllr Durbar proposed, seconded by Cllr Barraclough to accept the quotation from the website provider of a £200.00 setup fee and £20/ month running costs.

- iii. Update on CE Community Governance Review. The clerk noted that the CGR consultation period had now closed (November 28th). After contacting the head of CE democratic services, it was reported that circa 4000 responses had been received across the borough to the CGR consultation. Noted that all 5 MPs for Cheshire East had voiced their objection to the CGR and any proposed merger of Parish/Town Councils. Handforth TC is awaiting a response from MHCLG regarding the 1972 LGA which states that any proposed merger must have the agreement of all the Parish/Town Councils affected by such a proposal.
- iv. Chorley Village Hall. Cllr Beever noted that the village hall had lost some bookings and could possibly have one evening a week free. If it suited CPC she would work with the village hall committee to attempt to secure one evening a month for CPC to meet at the hall.
