MEETING OF CHORLEY PARISH COUNCIL Wednesday 21st October 2020 7.30pm at the Belmont Suite, Festival Hall, Alderley Edge

MINUTES

Present: Cllr Barry Durbar (Chair of Chorley Parish Council), Cllr Helen Keefe & Cllr Simon Watkins Also Present – Ashley Comiskey Dawson (Clerk)

1) To receive apologies for absence. 20/068

Apologies received from Cllr Richard Barraclough.

2) To receive Declarations of interest and requests for dispensation to discuss, or discuss and vote on a matter in which a Member or co-opted Member has a Disclosable Pecuniary or non-pecuniary interest (DPI): 20/069

Cllr Watkins proposed, seconded by Cllr Durbar to approve and sign the minutes of the Parish Council meeting held on the 16th September 2020.

Motion carried: Two in favour with one abstention.

5) To receive a report from the PCSO. 20/072

Incidents of note:

- 28/09/20 gardening equipment stolen from shipping container at address on Knutsford Road.
 Offence believed to have occurred within the last four months. No evidence available to support an investigation.
- 01/10/20 report of a male carrying a knife close to Lindow cricket ground. Area search conducted but no suspect found. No other calls.
- 02/10/20 report of insecure vehicle on Upcast Lane. Area search made but the vehicle could not be located.
- 08/10/20 theft of York stone paving slabs from address on Upcast Lane. On 09/10/20
 Offenders removed one further stone from the same location before being disturbed by
 occupant. Enquiries ongoing, crime prevention advice given and Cheshire Police Rural Crime
 Team made aware.
 - In recent weeks there have been numerous York Stone thefts that have taken place around the Mobberley and rural Knutsford areas for which arrests have since been made. York Stone thefts are a difficult crime to prevent; perhaps the most effective action is to mark individual stones before they are set with an original identifier (property marking products such as SelectaDNA are available online, but any irremovable mark such as engravings or paint of the owner's initials with a different number per stone e.g. JLM 1, JLM 2, etc. may deter thieves and could help to return stolen property if the owner can be conclusively confirmed. In this instance, photographs of each marked stone should be taken and stored and signs erected to deter offenders). If stones are already set, it should be made sure that they have been firmly put in place. Otherwise, standard property protection measures including locking gates, good lighting, CCTV and reporting suspicious vehicles/people should be followed. More measures can be found on the Cheshire Police website.
- 10/10/20 member of the public reported being splashed with water by a vehicle driving through a puddle. Judged not to be a crime so no further action taken.

Other issues:

- Speed enforcement for Knutsford Road remains suspended due to Cheshire East Council being unable to produce a copy of the TRO to police. I have raised this again with CEC Traffic Management Officer Robin Johnson and I await a reply.
- As has been outlined by the Police and Crime Commissioner, each ward area in Cheshire will have a dedicated PCSO and PC. The officers for Wilmslow West and Chorley are PCSO 22573 James Morris and PC 5951 Sam Mutch.

- ii. Update on Alderley Edge PC newsletter. Cost for distribution in Chorley to be £200.00 Councillors were happy with costs and it was thought that the leaflets would be distributed over the coming weekend.
