The clerk further noted that the Cherry Trees adjacent to Knutsford Road just prior to Dingle Avenue were appropriate for wrapping with Christmas lights and was pursuing a quote for this if it were of interest to councillors (there was also power available at the location from a Chorley PC owned street light column), the project could also be undertaken in-house if necessary. Councillors were in favour of having the trees wrapped at the location as this would be a permanent install with at least five years lifespan.

We Chorley Parish Council, have no objections to the Application made under reference No. 22/1093M Christopher Jackson Ltd, Knutsford Road, Alderley Edge. Cheshire. We do, however, have a number of concerns regarding the traffic safety of those delivering, collecting, and shopping at the premises once it is a tile and associated product outlet. The location is very close to a busy mini roundabout which currently takes a large quantity of traffic either travelling through the area and/or those using the services of the Beauty Salon and Horticultural sales shop which are both close by. It would be helpful, if permission were granted that the road lineage be reestablished so that traffic will adhere to the no stopping, no waiting areas. (The lineage is currently very faint and could be misunderstood) It would also be helpful to understand how the Applicant will manage safely deliveries and the unloading of materials so that there is minimum risk to traffic. May we suggest that as part of the permission that the Applicant is asked to provide a detailed plan for Customer parking, deliveries, and collections. Chorley Parish Council.
