MEETING OF CHORLEY PARISH COUNCIL Wednesday 14<sup>th</sup> September 2022 at 7.30pm The meeting was held at Lindow Primary School, Chorley, Alderley Edge.

### **MINUTES**

1) Apologies for absence: 22/085

Apologies received from Cllr Barry Durbar.

2) To receive Declarations of interest and requests for dispensation to discuss, or discuss and vote on a matter in which a Member or co-opted Member has a Disclosable Pecuniary or non-pecuniary interest (DPI): 22/086

4) To approve and sign the Minutes of the Parish Council meeting held on the 20th July 2022: 22/088

Cllr Connor proposed, seconded by Cllr Rainey to approve, and sign the minutes of the Parish Council meeting held on 20th July 2022.

Resolved: Unanimously.

5) To receive any updates from the PCSO. 22/089

Incidents of note:

- 29/07/22 Upcast Lane. At 03:08 dog disturbed person in back garden with torch. No offences identified and no link to other incidents.
- 12/08/22 Knutsford Road. Rogue trader failed to complete landscaping work leaving victim at least £1,500 out of pocket. Suspect identified, but victim did not support further action. When employing the services of a tradesperson it is always best to identify multiple people or companies with the relevant qualifications to perform the job, as well as gathering and comparing price quotes. #### Other issues:

- Speed enforcement was permitted to recommence on Knutsford Road on 4th August. Since then, the TruCam speed enforcement camera has been deployed twice, recording 11 vehicles.
- Parking patrols around Lindow Community Primary School have restarted following the summer holidays.
- 6) To receive any updates from Ward Councillors. 22/090

Cllr Mark Goldsmith reported the following: CEC had anticipated in their budget that employees would most likely be receiving a 2% pay increase, however, owing to the cost-of-living crisis this was looking to be more like a 7% increase. There was no information currently available as to whether councils will be entitled to a capping in the cost of energy bills in line with the governments household rollout and this will put enormous financial strain on all councils. CE are considering that if they don't receive a cap on energy bills they may have to close swimming pools through the winter along with a range of other energy saving measures. Cllr Goldsmith noted that CE has come out of the Covid-19 pandemic in a fairly strong financial position, however because of these factors further strain would be put on budgets and resources within CEC. He noted that CEC will be launching its speed awareness strategy consultation and that resulting from this it would be easier for the installation of SID's in various locations throughout the borough. He also noted that in the next financial year all ward councillors would be receiving approximately £6,500.00 to address immediate highways problems in their wards. The current rollout had been difficult as there had not really been a process in place to allow ward councillors to spend their allocations and any spend had been resisted by highways officers. However, councillors were very much in favour of the scheme following this pilot in recent years. Cllr goldsmith also noted that the plans to build a new car park in Wilmslow had been abandoned owing to largely reduced levels of use in the current car parks. This is because of greater working from home by companies as well as fewer commuter trains running to London. Cllr Goldsmith also reported that CEC were still looking to build a traveller site outside Middlewich and indicated that they were reviewing the waste and recycling strategy to see if any improvements could be made regarding the current waste and recycling centres and whether Wilmslow needed a new centre.

### 7) Matters Arising 22/091

- Position of TROs within Chorley. Fully reinstated as per PCSO indication of speed enforcement recommencing.
- ii. To discuss and agree necessary investigation and maintenance of problematic trees on the Row of Trees site. Cllr Connor met with a local resident and a tree surgeon on site to discuss the issue. It was noted that the trunks of the trees had been damaged by a machine at some point leading to the roughing of the bark of the mountain Ash (Rowan) trees. This allowed a fungus to spread to all the trees and has fully infected the soil. It was recommended that all the trees at the site be fully removed and replaced with a variety not susceptible to this type of fungus. A variety of Silver Birch called Jacquemontii was recommended as a suitable replacement. Cllrs Connor and Wilkinson will look into obtaining quotes for the full removal of all the trees on site, as well as quotes for replacements with the Jacquemontii variety.
- iii. To discuss any actions for the Handyman Cllr Rainey will purchase the Daffodil bulbs previously authorised by the council and the handyman to plant. It was also requested that the handyman weed spray along Knutsford Road, as the CEC weed spraying appeared largely unsuccessful and the handyman was also requested to begin leaf blowing as the trees were loosing their leaves.
- iv. To update councillors regarding installation of Christmas lighting for 2022.- The New 2022 Christmas lights have been installed and there is scope for lighting installation of the fourth tree. The electrician is booked to attend site on 15<sup>th</sup> September to convert the street light column and to provide socket and timer for the lights.
- v. Update on swing in Beswicks Lane Park. The missing swing was reinstalled by ANSA over the summer, noted the new swing looks exactly like the one which was removed earlier in the year.
- vi. Update on Community Defibrillator at Lindow CP School. A donation was made by CPC to the school, which was gratefully received, and the new parts have now been fitted to allow the defibrillator to return to full working use.

### 8) Highways Issues 22/092

- I. Pavements Incursions and overgrowth Handyman to cut back along corner with Cressey's Grains.
- **II.** Road Markings Councillors to provide a list of replacement road markings to Cllr Durbar which will be escalated to Cllr Goldsmith for inclusion in future highways scheme.

Noted that councillors felt that they would undertake the distribution of the Chorley Chat, therefore there would be a much-reduced cost than that authorised, and this would be simply down to the professional printing of the newsletter. Draft to be returned to the clerk by month end September, with a view to printing and distribution circa October 7<sup>th</sup>.

- 22/2792M RED BEECH HOUSE, 78, KNUTSFORD ROAD, ALDERLEY EDGE, SK9 7SF We, Chorley Parish Council have carefully considered the details of Planning Application No. 22/2792M and, as a result continue to hold the position that we object to this development as we did with the previous application for this development under Ref. 22/0441M. The reasons for our objection remain as previously stated and are that we believe that this is 'New Build' situated on Green Belt land. We also have significant concerns regarding access. The proposed location, we believe is intrusive to the nearby Neighbours properties and the negative effect it will have on their ability to enjoy their own homes. The access track to the proposed site is extremely narrow and is already constrained by others accessing their properties. We would strongly suggest that the allocated Planning Officer views the location in person in order to full appreciate the location/access issues/Neighbour proximity/Traffic flow and current usage.

Should the application be approved we would ask for the following to be part of the conditions of approval.

- \* Clarification is required to establish who owns the track where the development is proposed and we would recommend that once this is understood then a legal document is created regarding long term access for all affected, it is agreed and signed off by all affected parties.
- \* We would also ask that conditions are set that access remains clear for Neighbours at all times during and after construction.
- \* Contractors are not to block access or carry out works outside agreed times.
- \* Care is taken to keep the access track in good order during the Construction and the Applicant leaves the track in good condition.
- c) 22/3245M PLUM TREE COTTAGE, GORE LANE, ALDERLEY EDGE, SK9 7SP - We, Chorley Parish Council have no objections to Application No. 22/3245M relating to a development at Plum Tree Cottage, Gore Lane, Chorley, Alderley Edge.

22/3251M CEMETERY LODGE, CHELFORD ROAD, CHORLEY, CHESHIRE, SK9 7TQ - We, Chorley Parish Council fully support the development of the Cemetery Lodge, Chelford Road, Chorley, Alderley Edge which has been applied for under Application No. 22/3251M. A number of our members have actually stated that it will be a vast improvement on the building which is currently in a state of disrepair. We would also like to add the following comment for the deciding Planning Officer to take into account when making their decision. Much of the work will be undertaken around the single access point to the Cemetery. This remains an active Cemetery with numerous burials throughout the week and frequent Visitors during the week and at weekends so it will be very important that during the works that the Developers are kept informed in advance of funerals so they may show respect and keep the access clear for the mourners. It will also be important that Visitors to the Cemetery can gain access too. Chelford Road is a busy road with a great deal of fastmoving traffic, any delays in getting access in and out of the Cemetery may lead to road traffic accidents.

As a long-term consideration when the building becomes two separate dwellings, again, access should be kept clear at all times.
