MEETING OF CHORLEY PARISH COUNCIL

The meeting was held at Lindow Primary School, Chorley, Alderley Edge.

## **MINUTES**

Present: Cllr Richard Barraclough, Cllr Barry Durbar (Chair of Chorley Parish Council), Cllr David Connor, Cllr Richard Stain & Cllr Sophie Wilkinson.

1) Apologies for absence: 22/115

Apologies received from Cllr Rainey and Gould.

2) To receive Declarations of interest and requests for dispensation to discuss, or discuss and vote on a matter in which a member or co-opted Member has a Disclosable Pecuniary or non-pecuniary interest (DPI): 22/116

Cllr Wilkinson declared a personal and pecuniary interest in planning application 22/4740M and will not take part in any debate or vote on the application.

5) To receive any updates from the PCSO. 22/119

The PCSO reported the following Incidents of note:

The only incident of note relates to a member of the public entering a business on Knutsford Road and shouting and swearing at staff about parking on the road. Staff at the business have also raised concerns about receiving rude notes attached to their cars after finishing work, despite apparently parking legally. Inevitably, if the businesses around Knutsford Road and Brook Lane are preforming well they will bring an increased number of customers into the area who, due to limited parking spaces, will park on Knutsford Road. Apart from the yellow lines near the roundabout there are no parking restrictions on the road, so unless vehicles are obstructing the road or pavement they are not committing any offences (obstructions can be reported to police by telephoning 101). I am aware that the salon on Knutsford Road is looking to try to acquire off-road parking locally and I have asked Cllr. Wilkinson if a message could be distributed to residents to encourage courtesy, tolerance, and respect in order to prevent an escalation of behaviour.

- Patrols around Lindow Community Primary School during drop-off and pick-up times continue.
