1) Apologies for absence: 24/016

Apologies received from Cllrs Connor & Rainey.

Apologies received from Cllr Horsey, it was noted by all councillors present that Cllr Horsey had not attended a meeting of Chorley Parish Council for Six consecutive months and had therefore, self-disqualified as a councillor. The clerk will notify Cheshire East Council electoral services that Chorley Parish Council now has a casual vacancy.

#### Incidents of note:

- 04/03/2024 Chelford Road. One-vehicle Road traffic collision where car flipped onto its roof.
   No injuries and believed caused by ice and mud on road.
- 14/01/2024 Knutsford Road. Report of large explosion. Police, fire, and electrical engineers attended, and the cause was found to be a malfunctioned electricity substation in Alderley Edge.

## Other issues:

- Speed enforcement with TruCam was carried out on Knutsford Road on:
  - o 10/02/2024 1 activation.
  - o 04/03/2024 7 activations.

All vehicles have been sent for processing by the Central Ticket Office at HQ which will decide further action to be taken by the drivers: no further action, course, points and a fine or court.

#### 6) To receive any update from Wilmslow West and Chorley Ward Members. 24/021

Cllr Goldsmith reported the following, that CEC have approved the new ward boundary proposals and that these have been submitted to the Boundary Commission. CEC have also approved their new balanced budget for 24/25. A new CEO has been appointed at Cheshire East who was driving cost saving initiatives around paperwork and the use of Al. Noted that subsequent to the cancellation of HS2 the government has announced a sum of money to be allocated to CE Transport and Highways of £186 million over the course of the next 8 years. Also noted that Cllr Browne has stepped down as deputy leader of CEC and Cllr Gorman has replaced him as deputy leader and has also assumed the role as chair of the Economy and Growth committee. Cllr Goldsmith has now assumed the role as the chair of the highways committee.

# 7) Matters Arising 24/022

- i. Update on deed of easement with the developers of the Laburnum Farm site. Positive Certificate Granted, however still awaiting full planning permission, case officer is on leave at present.
- ii. Update on the CEC Ward Boundary Review. Noted that CE have approve the ward boundary proposals for Cheshire East, if any resident wishes to make further representation to the new ward boundary proposals, this will have to be done through the Boundary Commission website.
- iii. CPC Involvement with Lindow 40<sup>th</sup> Anniversary. no update, although they have received £250,000.00 in grant funding.
- iv. Skip on Dingle Avenue. CPC to determine who is responsible for the skip and request its removal as it is full and there is another large volume of material adjacent to the skip and debris from the skip is causing littering problems on Dingle Avenue and Knutsford Road.

- vii. To discuss the hedge cutting at Dingle Avenue. completed by Parish Ranger.
