## **MINUTES**

The PCSO provided the following report: Cheshire Constabulary

Chorley Parish Council report 4th December 2024

Incidents of note:

- 01/11/24 burglary, Knutsford Road. Offenders opened back gate of property and snapped lock on UPVC door to access house, making an untidy search and taking a wallet, jewellery box and car keys. Enquiries are continuing and the offence is believed to be linked to another burglary in Knutsford. Crime prevention advice delivered to nearby residents.
- 26/11/24 commercial burglary, Knutsford Road. Two quad bikes stolen from shed. Also, 5th November: theft of off-road buggy from same location. Enquiries continue.
   Other matters:
- I have been monitoring for parking obstructions on Knutsford Road following the concerns raised at the previous meeting. Two vehicles have been issued Fixed Penalty Notices for obstruction of the pavement, while a further two drivers were advised and moved on. I will continue patrols.
  - Speed enforcement with TruCam was carried out on Knutsford Road on:
- o 11/11/2024 three activations.
- o 21/11/2024 one activation.
- o 30/11/2024 six activations.

All vehicles have been sent for processing by the Central Ticket Office at HQ which will decide further. action to be taken by the drivers: no further action, course, points and a fine or court.

Cllr Connor noted that there had been a theft of Yorkshire paving stone from No.11 Knutsford Road which has been reported to the police.

#### 6) To receive any update from Wilmslow West and Chorley Ward Members. 24/135

Neither Wilmslow West and Chorley Ward member was in attendance at the meeting, however the clerk provided a brief update on matters from CEC:

- Following committee decision black bins will now be collected on a three-weekly basis.
- The library opening hours at Alderley Edge library have been cut to 1.5 days per week, AEPC operate a volunteer session for one half day and will provide top up funding to allow 0.5 days extra provision. Wilmslow library will remain open as usual.
- Car parking charges across the borough came into effect as of the 02<sup>nd</sup> December 2024, previously free
  car parks will now be charged by CEC and charges on other car parks will be updated.

## 7) Matters Arising 24/136

- i. Update on deed of easement with the developers of the Laburnum Farm site. No new update.
- ii. Footpaths & Bridleways. PROW Network manager has been in touch with CPC and provided a course of action which they will be taking. Cllr Rainey will monitor progress and report back.
- iii. Footpath adjacent to Prospect House. PROW Network manager has been in touch with CPC and provided a course of action which they will be taking. Cllr Rainey will monitor progress and report back.
- iv. Receipt of a noise complaint from Prospect Cottages. Resident advised to contact CEC in the first instance.
- v. Any other matters and jobs for parish ranger. Cllr Connor has requested clearance of road debris between Brook Lane RAB and Row of Trees, street sweeping from CEC to follow, then clearance of leaves on Dingle Avenue.
- vi. Update from Cllr Connor regarding the Lindow Trust. Cllr Connor noted that there were circa 12/13 trustees with different backgrounds and that the Trust has been in existence since the 1700's. It had a pot of money to assist those in hardship in the area of benefit. Information was circulated to all councillors and advised that if they were aware of any cases in the area who would benefit, to contact Cllr Connor, Lindow School and local scout groups were to be contacted to inform them as well.

### 8) Highways Issues 24/137

- I. Flooding of Foden Lane. Area of flooding around Whitehall Brook remains the same, CEC have tarmacked the area, however this is insufficient. CPC are aware of the broken land drains causing surface water run off onto the road, however CEC would be required to contact landowners in this respect. Surface water from the Foden Lane would need to be directed into traps under the bridge before discharge into Whitehall brook, however this is a costly undertaking, and CEC will not be able to finance this for some time. Flooding at the northern end of Foden Lane CPC believe that CEC have completed drainage investigations and root cut back throughout the drainage system in this area, however, there has been little rainfall to observe whether this has corrected the flooding problem in this area. - II. Sink Hole on Foden Lane. CEC have completed the infill of this sink hole.

## 9) MOTION: To insert additional text into the CPC/NALC Model Financial Regulations 2024. 24/138

- 4.2. No expenditure may be authorised that will exceed the amount provided in the revenue budget for that class of expenditure other than by resolution of the council, or duly delegated committee.
- 4.8. The RFO shall regularly provide the council with a statement of receipts and payments to date under each head of the budgets, comparing actual expenditure to the appropriate date against that planned as shown in the budget. These statements are to be prepared at least at the end of each financial quarter and shall show explanations of material variances. For this purpose, "material" shall be in excess of [£100] or [15%] of the budget.
- 4.10. The agreed budget provides a basis for monitoring progress during the year by comparing actual spending and income against what was planned.

Cllr Barraclough proposed, seconded by Cllr Rainey to insert the additional text (as above) into the CPC/NALC Model Financial Regulations 2024.
