### MINUTES

**1) Apologies for absence: 18/124**

Apologies received from Cllr Rainey.

**2) To receive Declarations of interest and requests for dispensation to discuss, or discuss and vote on a matter in which a Member or co-opted Member has a Disclosable Pecuniary or non-pecuniary interest (DPI): 18/125**

**4) To approve and sign the Minutes of the Parish Council meeting held on the 17<sup>th</sup> October 2018: 18/127**

Cllr Maxwell proposed, seconded by Cllr Barraclough to approve and sign the minutes of the meeting held on 17<sup>th</sup> October 2018.

**Motion carried: Two in favour with two abstentions.**

**5) To receive a report from the PCSO 18/128**

The PCSO reported the following incidents of note:

16/10 at the Cricket club there had been an altercation between two dogs and subsequently their owners.

29/10 there was a report of torches being shone through the windows of residents – this was thought to possibly be dog walkers.

10/11 theft of a mini digger from outside the development at No.74 Knutsford Road.

14/11 report of two suspicious males on Gore Lane.

18 & 19/11 report of horses loose on Knutsford Road.

The Trucam has been out 3 times and had 11 activations.

Noted that school parking is still an issue, the PCSO has been down and spoken to parents on several occasions, also the PCSO will contact CE parking enforcement as they need to be involved more and attend at Lindow Primary.

**6) Matters Arising 18/129**

i. Cemetery Gatehouse - No Update.

ii. Upcast Lane Parking Issues. – PCSO Report.

iii. Manchester Airport S106 agreement – Cllrs have read through this document and it was agreed that Cllr Rainey and Cllr Maxwell would attend the proposed meeting to be held in January.

iv. ChALC AGM – Update. – Cllr Durbar has circulated his report from this meeting.

v. Further items re: development at no.74 Knutsford Road. – It was noted that the developer had written to CPC asking them to sign an easement, however the parish council are agreed that they will not sign any further legal documents granting any easement for utilities across the common land. The deeds were sent to Macclesfield town hall but have been forwarded on to the clerk.

vi. Update on progress with new Chorley Sign. – 50% deposit has been paid for the new Chorley sign and this is currently being manufactured.

- vii. Update on progress with new Noticeboard. – The new parish council noticeboard has now been installed.
- viii. Update on Chorley Road Signs. – Cllr Barraclough reported that most of the Chorley boundary signs were in good order. The boundary sign outside Lavinia court was fixed earlier this month. It was agreed that the clerk and handyman would move the CE brown signs into more appropriate places in the New Year.

## 7) Highways Issues **18/130**

- i. Consolidated List attached as a separate spreadsheet. – Updated

Need to reopen the job concerning Brook Lane Roundabout – road surface and lining is in a poor state of repair. Knutsford Road requires a road sweeper to attend; there is a build-up of gravel near the Brook Lane RAB. The hedge which CPC requested to be cut near Dingle Avenue was attended to by CEC, however only two thirds of the work was completed.

The blocked grid outside Avocet Steel – Jeremy Hough met on site with UU and now has permission to connect the drain into the UU system. He is hopeful that this will be achieved by the end of this financial year.

## 8) MOTION: To discuss the purchase of a new Speed Indicator Device and review quote received. **18/131**

Cllr Maxwell noted that CPC was in receipt of a quantity of money and could now afford to purchase a new SID. Cllr Durbar was concerned about the cost, however recognised that this was the most appropriate way of addressing the concerns of speeding for local residents. As the community speed watch incentive had failed, at least this was a way of automatically monitoring speeds along Knutsford Road. The information obtained from the SID can be forwarded on to the PCSO and he could then target hot spots with the enforceable Trucam Gun.

Cllr Maxwell proposed, seconded by Cllr Watkins to purchase the Speed Indicator device for the quoted price of £2,555.00 plus VAT.

### 2) New Applications: **18/133**

- a) **18/5426M** - CARR FIELD FARM, CARR LANE, ALDERLEY EDGE SK9 7TQ - Construction of a single storey rear extension, construction of proposed porch and conversion of existing garage.

We, Chorley Parish Council have been asked to comment on Planning Application No. 18/5426M relating to Carr Field Farm, Carr Lane, Alderley Edge. As per our previous comments in an earlier application, we believe the actual building element of the property lies within the Parish of Alderley Edge whilst much of the land associated with the Farm lies within the Parish of Chorley. To that end we would like to re-confirm (as we did in Application No. 18/2882M) that we have no objections to the proposals.

We do, however, have a comment to make regarding the naming of the property on the Applications. In 18/2882M the property is named Carr Field Farm. In this recent Application (18/5426M) it is named Carr Field Farm The Barn.

Historically, it is our belief that prior to the conversion of the barn the whole farm was named Common Carr Farm and the farmhouse is a listed building. In recent years, since the Barn conversion and the splitting of the property the Farmhouse has been renamed Carr Field Farm. We would ask that clarification is made on which property this Application relates to and it is clearly documented for accurate reference.

It has been reported to councillors that the Neon Gym at 103-105 Brook Lane has started to prepare food and begin a takeaway service. This is in breach of planning conditions and has been reported to CE enforcement by CPC and Alderley Edge Ward Councillor Craig Browne.

As CE enforcement has yet to take action it was agreed that the clerk write to Sean Hannaby to enquire as to why this serious matter has not been addressed.
