PCSO James Morris attended the meeting and reported the following incidents of note:

- Reported incident of escaped sheep on Chelford Road, a gap was found in the boundary fence.
- A resident had collapsed on Upcast Lane; however, he did not require any assistance and was returned home.
- Animals had been dumped by the gate at Ten acres.
- Noted that there were a number of instances of fly-tipping around the area which needed to be reported to CE.
- Noted that Lindow school had reopened for the autumn term and that patrols had been increased to ensure child safety.
- Noted that Knutsford Road had been coned along both side on 8th & 09th September for the Cycle tour of Britain which was passing through at approximately 2:30pm on 09th September.

Cllr Barraclough is finalising a circular to be distributed to all residents of Chorley which will be in an envelope marked "Important" and "please respond". This circular will encourage all residents to make representations to the CE community governance review. It will also encourage residents to contact the Parish Council to make their views known and that a final representation would then be formed and sent to the CGR consultation on behalf of CPC reflecting the majority view.

Noted that it is felt any merger with Wilmslow will both increase the tax burden on Chorley residents and will remove any voice that Chorley Parish Councillors currently have on an enlarged Wilmslow Town Council.
