**MEETING OF CHORLEY PARISH COUNCIL
Wednesday 13th October 2021 at 6.30pm**

The meeting was held in the Belmont Suite at the Festival Hall, Alderley Edge.

MINUTES

Present: Cllr Richard Barraclough, Cllr Sophie Beever, Cllr Barry Durbar (Chair of Chorley Parish Council), Cllr Helen Keefe & Cllr Margaret Rainey

1) Apologies for absence: 21/080

None.

2) To receive Declarations of interest and requests for dispensation to discuss, or discuss and vote on a matter in which a member or co-opted Member has a Disclosable Pecuniary or non-pecuniary interest (DPI): 21/081

A resident noted that he was horrified by the proposal, and they had a friend on North Rode Parish Council who were facing a comparable situation regarding a merger with their neighbouring parish council. He was pleased that both their MP and the local MP for Tatton were on the side of the respective councils. He suggested getting some signs made up and possibly both a Facebook page and an online survey.

Another resident enquired about a further leaflet drop.

A resident enquired as to how the Parish Council corresponded with residents in general. The chairman noted that the Parish council had both the noticeboard and website.

- 06/10/21 – Dingle Avenue. Alarm activation. Officers attended and concluded it was a false alarm.
- 11/10/21 – Dingle Avenue. As above.

6) Matters Arising 21/085

- i. Update on cemetery gatehouse. – No update
- ii. Update on a new Parish Council Website – request sent to ChALC. – It was agreed that Cllr Beever would progress this and enquire about the basic website package. The parish council were keen to move forward and would hopefully be able to bring a resolution to the December meeting.

- iii. Update on CE Community Governance Review. – It was agreed that having only spent circa £400.00 of the budgeted £700.00 on the leaflet drop, the council would have 200 leaflets printed up encouraging residents to comment on the CE CGR as a reminder, these would be hand delivered. Also, the council would have 6 x large Correx boards made up advertising the CGR to be placed round Chorley parish.

He has asked the parish council for any further comment before submitting to the highway authority for authorisation to take enforcement action. The Parish Council fully agreed that if it was deemed to be an encroachment, then formal authorisation should be requested for enforcement action to take place.

9) **MOTION:** To agree the CPC response to the Cheshire East Council Community Governance Review and submit to the consultation. Based on the initial communication to residents and the majority of responses received. **21/088**

Noted that whilst the CPC leaflet had requested residents to fill out the CGR survey online, CPC had requested that residents contact the parish council with their views. CPC has received a 13% response rate from residents of which 100% were against any merger proposal with Wilmslow and Handforth. CPC find this an incredible response from residents who are in support of the Parish Council remaining an independent body. It was agreed that CPC would add this detail in to the currently agreed response and formally submit the circulation in its current form via the clerk.
