MINUTES

1) Apologies for absence: 21/052

2) To receive Declarations of interest and requests for dispensation to discuss, or discuss and vote on a matter in which a member or co-opted Member has a Disclosable Pecuniary or non-pecuniary interest (DPI): 21/053

Incidents of note:

- 06/07/21 Knutsford Road. Concern for safety of elderly female. Returned home safely by member of public.
- 07/07/21 Upcast Lane. Report of large group of people acting anti-socially. Officers attended and dispersed the group.

Other issues:

- PC Claudia Bolton has joined the neighbourhood team, also aligned to Wilmslow West and Chorley.

6) Matters Arising 21/057

- i. Update on cemetery gatehouse. – No further update.
- ii. Update on a new Parish Council Website – request sent to ChALC. The clerk has received feedback from ChALC and has been provided with a web design company. Cllr Beever is going to speak to the provider to discuss options.
- iii. Update on CE Community Governance Review. – The clerk reported that at the full CE council meeting held on 22nd June 2021 CE voted against paying for any referendum to be held by an individual town or parish council and instead expected this burden to be shouldered by the town/PC. This did not preclude any town / PC who wished to pay for one themselves.
Also noted was the fact that the consultation had still not been launched, despite CE wishing the matter to be resolved in Autumn and that the consultation period would run for 12 weeks. It seemed unlikely that the consultation will now launch until September.

It was agreed that Cllr Barraclough would begin work on a letter to each household in Chorley stating the Councils position on the matter and would highlight the pros and cons of the proposed merger; along with a request to submit the views of the households to the consultation portal. However, this could not be circulated until CE had published the consultation.

- iv. Update on using Lindow School for meetings from September 2021. – Noted that Lindow school are happy for the parish council to return to using their staffroom for council meetings from September 2021. Councillors agreed that they would continue using the Festival Hall for the time being and certainly their September meeting.
- v. Chorley Village Hall. – Cllr Beever noted that she would be attending their AGM next week.
- vi. Cheshire Archive. – Cllr Rainey will contact Cheshire Archives to see if they can take some of CPC's old paperwork.
- vii. Climate Hub. – Not discussed.
